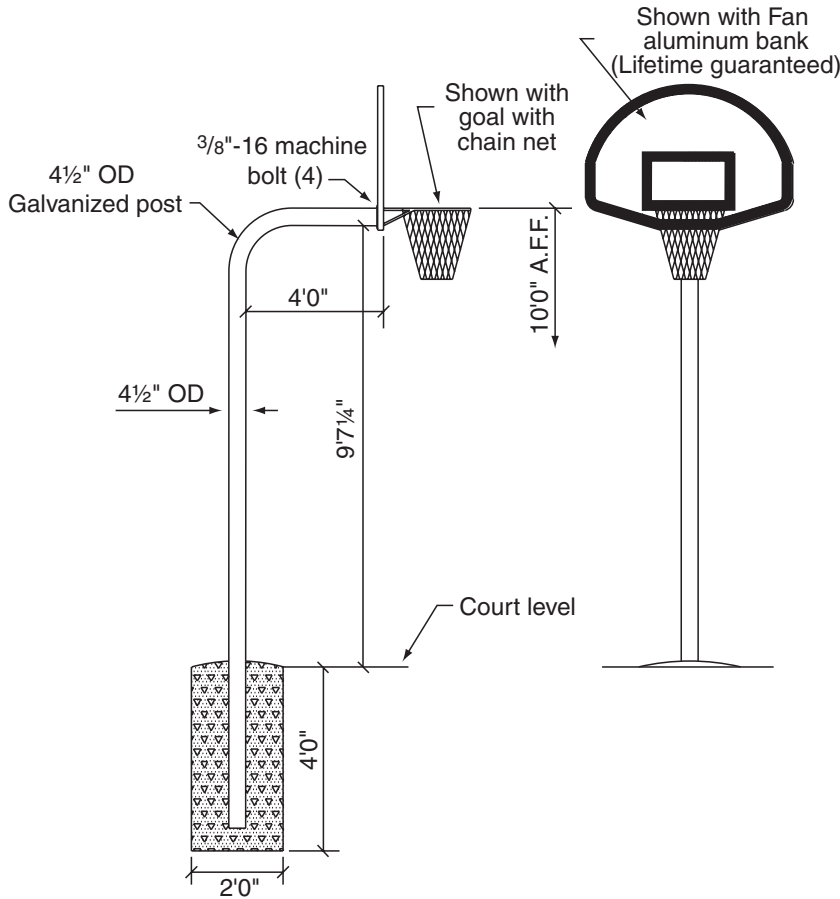

### Product Description

Basketball Backstop shall be the 5063XY Outdoor Backstop by Draper, Inc. Spiceland, IN.

5063XY Backstop shall have a 4½" OD heavy-wall galvanized post with an approximate 18" radius to extend the face of the backboard 4'0" from the front edge of the post. The backboard and goal bolt directly to the post forming a solid unit that transfers loads to the heavy-duty steel post to eliminate strain on the backboard.

XY indicates the backboard and goal. Backstop available with a variety of backboards and goals per chart below.
