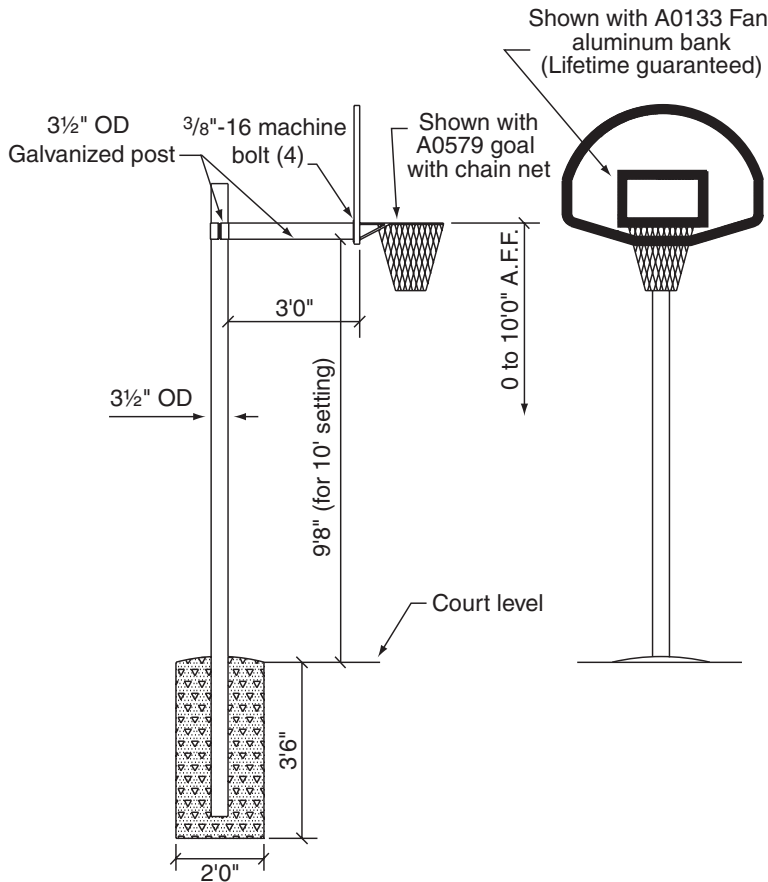

Product Description

Basketball Backstop shall be the 5066XY Outdoor Backstop by Draper, Inc. Spiceland, IN.

5066XY Backstop shall have a 3½" OD heavy-wall galvanized post with a 3' adjustable height 3½" OD extension. Post is capped for protection from weather. Extension can be installed from 0' to 10' above court level. The backboard and goal bolt directly to the extension forming a solid unit that transfers loads to the heavy-duty steel post to eliminate strain on the backboard.

XY indicates the backboard and goal. Backstop available with a variety of backboards and goals per chart below.
