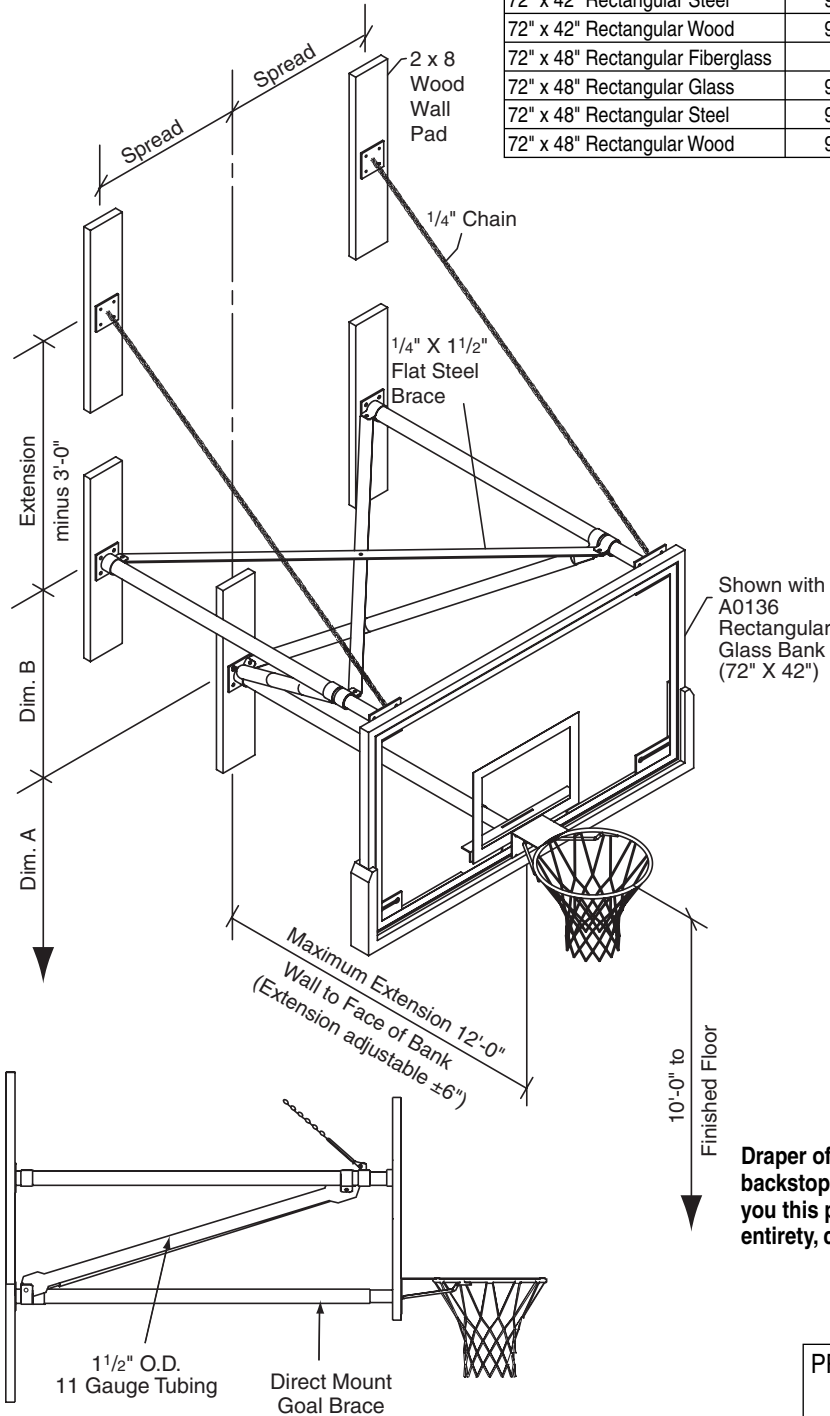

Specifications—EZ Fold SWD

Wall-Mounted, Stationary Backstop with Direct-Mount Goal Brace

Product Description

SWD Stationary, _____ required. Backstop shall be the EZ FOLD Model SWD, with face of backboard _____ ft. _____ in. from support wall (1' [30.48 cm] to 12' [365.76 cm] extension available.)

Backstop shall be rigidly suspended from 3 fixed points on the wall. The bank shall be braced from the wall by two legs consisting of 2½" (6.35 cm)-13 gauge O.D. steel mechanical tubing and mounted to the upper right and left rear corners of the bank, and one leg consisting of 2½" (6.35 cm)-13 gauge O.D. steel mechanical tubing and mounted behind the goal. This third leg will serve as a direct mount goal brace, transferring stress loads directly from the goal to the backstop frame.

On extensions greater than 3'0" (91.44 cm), backstop shall be supported in playing position by two ¼" (6.35 mm) welded-link chains w/turnbuckles for additional support. Legs shall be adjustable for a plus or minus 6" (15.24 cm) variation of distance from face of bank to wall.

Legs shall be further braced by ¼" x 1½" (6.35 mm x 3.81 cm) flat steel cross braces and two 1½" (3.81 cm) O.D. 11-gauge diagonal brace tubes terminating in precision die-formed clamps. Frames shall have black or white powder coat finish. Other colors optionally available; contact Draper for details.

Backstop shall be provided with 2 x 8 (5.08 cm x 20.32 cm) southern yellow pine wall pads at wall attachment points. On extensions greater than 3'0" (91.44 cm), 2 x 8 (5.08 cm x 20.32 cm) southern yellow pine wall pads shall be provided for welded-link chain attachment. All edges shall be chamfered and pads shall be finished with high gloss polyurethane.

Options

Backstop can be provided with any of several different styles of backboards, goals and padding. Specify types desired. See separate sheets.
