Please review the fabrics below, which comply with the Massachusetts regulations.  
Swatch cards are available upon request.

**ATF-2500** – 1% openness. Matches Phifer SheerWeave 2500 in the 5 colors below.

**ATF-2400** – 3% openness. Matches Phifer SheerWeave 2400 (2410) in the 5 colors below.

**ATF-2900** – 5% openness. Matches Phifer SheerWeave 2900 (2390) in the 5 colors below.

- Oyster
- Oyster/Beige
- Oyster/Pearl Grey
- Charcoal
- Charcoal/Grey

**ATF E SCREEN** 0.5%, 1%, 3%, 5%, and 10% openness.

**E SCREEN DECO** 1% and 3%.

**ATF E Screen KoolBlack** 3% in Charcoal/Cocoa only. Matches Mermet E Screen KoolBlack.

**GREENSCREEN EVOLVE** 3%

**GREENSCREEN REVIVE** 1% & 5%

**S SCREEN** 1% and 4%

**SHEERWEAVE SW8000** 3%

**SHEERWEAVE SW7850 LIGHT-FILTERING**

**T SCREEN DECO** 1%, 3%, and 5%

**VIZELA** 1%

The fabrics below are recommended for **residential use only** (these do not meet commercial fire codes).

The fabrics below are typically used **outdoors**, but are free of antimony trioxide and meet NFPA701.
